
WaSH Bottleneck

## National Training of Trainers (ToT) Community Led Total Sanitation Workshop

The National Department of Health's Health Promotion Branch, with support from UNICEF and Feedback Foundation, successfully conducted two Community Led Total Sanitation (CLTS) Train of Trainers Workshop at the March Girls Resort in Gaire, from the 8<sup>th</sup> to the 12<sup>th</sup> of May, and in Jiwaka at Jiwaka Mission Resort, from the 15<sup>th</sup> to the 19<sup>th</sup> of May.

The workshop was attended by WaSH Stakeholders from the WaSH National Level Stakeholder including the DNPM WaSH PMU, Health Promotion & Extension Officers, and selected NGOs.

Papua New Guinea faces significant challenges in terms of sanitation access, making this training a crucial step forward. According to the JMP 2021 reports, only 19% of the population has access to sanitation, with just 16% practicing open defecation-free behaviours. This limited access has resulted in a deteriorating quality of life, including high rates of infant/maternal mortality and morbidity.

The goal of the CLTS Master ToT Training is to create Motivators by equipping participants with the necessary skills, knowledge, and various methodological approaches to trigger and sustain positive change. The training comprises an intensive two-day theory session followed by three days of hands-on practical sessions aimed at instigating change within the Gaire Community.

By fostering collaboration among government entities and NGOs, we can make significant strides in improving sanitation access and ultimately enhance the well-being of individuals and communities across the country.



### WaSH Joint Sector Review (JSR) Finalization

We are pleased to bring you an update on the progress of the first-ever WaSH Joint Sector Review process, conducted in partnership with World Vision. The main objective of this process is to develop WaSH Joint Sector Review (JSR) reports that aims to inform the government and policy makers about the sector's performance and advancements in line with the National WaSH Policy (2015-2030) at the national gatekeeper level.

The JSR Process involved an audit of the five essential building blocks that constitute a functional WaSH sector. These building blocks include, Institutional Arrangement, Sector Policy & Strategy, Capacity Development, Planning Monitoring & Review, and Sector Finance. Additionally, the JSR committee voted to include Gender Equality, Disability, and Social Inclusion (GEDSI), Climate Resilience, and Environmental Safeguards as another building block.

The selection of these building blocks was strategic, as they reflect the core strategies of the National WaSH Policy aligned with other national development frameworks such as PNG Vision 2050, Papua New Guinea Strategic Development Plan (2010-2030), and the Medium-Term Development Plan (MTDP).

To ensure a comprehensive assessment of the sector's progress, the JSR brought together all WaSH stakeholders through a Technical Working Group (TWG). This collaborative effort allowed the gathering of valuable information and facilitated an in-depth evaluation of the sector's performance.

The DNPM WaSH Programme Management Unit (PMU) and the World Vision team are currently in the process of finalizing the reports for endorsement from the Department of National Planning and Monitoring (DNPM).

# WASH, Water Security and Climate Change Integration Working Group 2<sup>nd</sup> Meeting

The WaSH, Water Security & Climate Change Technical Working Group recently convened its second meeting at the National Weather Service office. This platform brought together key stakeholders from health, education,

climate/meteorological, agriculture and development partners.

During the meeting, Takale Tuna, the National WaSH Program Coordinator for the DNPM WaSH PMU, emphasized the importance of incorporating climate change resilience into WaSH development and water resource management as part of the country's overall socio-economic planning. DNPM WaSH PMU will be spearheading efforts within the Technical Working Group to enhance preparedness and mitigate the effects of climate change on WaSH in the country.

The primary objective of the Technical Working Group is to integrate and share data among National key government stakeholders, including National Weather Service, Climate Change Development Authority, Conservation Environmental Protection Agency, National Department of Education, and National Department of Health.

This integration will be facilitated through the National WaSH Management Information System (MIS). By utilizing this system, the government aims to enhance preparedness and planning for climate change conditions, while ensuring that communities have access to clean water and climateresilient sanitation facilities.

The impacts of climate change have become increasingly evident across the country.

These include prolonged droughts lasting up to nine months in the NGI region, rising sea levels necessitating community resettlements, increasing atmospheric temperatures, and unpredictable rainfall patterns. Recognizing the ongoing reality of climate change, collaborative efforts led by the government are crucial to ensure that communities adopt climate-resilient practices.

As we face the challenges posed by climate change, it is imperative that we unite our efforts and work towards building a sustainable future.
